A 4-H Member MUST be enrolled in the Dodge County 4-H Program, Horse Project by THURSDAY, MAY 15

A 4-H Member MUST have completed the following by THURSDAY, MAY 15

- PASSED all portions of Level 1 and Level 2 Advancement Level Testing.
(ONLY Halter, Showmanship, Hippology Contest and Judging Contest are exempt.)
- 4-H Member MUST be 12 - 18 years old on January 1, 2008
- 4-H Member MUST HAVE SUBMITTED a proper **Identification Form (F 2-97-77)**

Special Notes:

- ONLY 4-H'ers that have passed Level 1 & Level 2 qualify for classes at DISTRICT HORSE SHOW CLASSES ("D").
- ONLY 4-H'ers that have passed Level 3 qualify for classes 20 - 33 at STATE 4-H HORSE EXPOSITION ("E").
- ONLY 4-H'ers that have passed Level 4 qualify for class 34 at STATE 4-H HORSE EXPOSITION ("E").
- * ONLY ONE pleasure class, ONE horsemanship/equitation class, ONE reining class, ONE pole bending class, and ONE barrel racing class may entered by a 4-H'er and/or horse.
- * Make checks payable to "UNL Extension"
District Fees = \$5.00 per class entered
State Fees = \$5.00 per class + \$3.00 per roping class + \$10.00 working ranch horse class
- * SIGNATURES of 4-H Member and Parent/Guardian. (Entries cannot be processed without authorization by the 4-H member, parent/guardian's AND extension educator's signatures at the bottom of each entry form.)
